**METHODS OF CONTRIBUTION OF THE SCHOOL
TO SISSA'S KINDERGARTEN "La SISSA dei Piccoli" FEES
FOR SISSA INTERNAL USERS**

We inform you that the SISSA Board of Directors, during the meeting held on January 29, 2015, considering the entry into force from January 1, 2015 of the new method of calculation of the ISEE, approved the following methods of contribution to the kindergarten fees for SISSA internal users, based on ISEE so-called "Minorenni":

| - I) ISEE from € 0 to € 25,000: | € 480.00 as SISSA monthly contribution; |
| - II) ISEE from € 25,000.01 to € 30,000.00: | € 450.00 as SISSA monthly contribution; |
| - III) ISEE from € 30,000.01 to € 35,000.00: | € 420.00 as SISSA monthly contribution; |
| - IV) ISEE from € 35,000.01 to € 40,000.00: | € 390.00 as SISSA monthly contribution; |
| - V) ISEE more than € 40,000.00: | no SISSA contribution. |

The above methods of contributions will be applied to all applications submitted after January 1, 2015.

Considered the first application of the new method of calculation of the ISEE, in the case of systemic impact of the results of the "new" ISEE-Minorenni, going to significantly change the balance between brackets of the ISEE and amount of the contribution of SISSA, the School reserves to adjust the amounts of the brackets, in order to maintain the balance between income groups and contribution.

The contribution will be paid directly by SISSA to the company managing the kindergarten.

SISSA reserves the right not to allow any contribution to holders of coordinated and continuous collaboration contracts who do not carry out their work activity mainly for the School.

The arrangements for submitting kindergarten admission applications to SISSA for the 2015/2016 educational year will be disclosed in the "Announcement for applications of SISSA internal users for enrolment in SISSA's Kindergarten", which will be published by the end of February.
